



**Job Title: Senior Telecommunications Expert**

**Position Overview and core responsibilities**

We are seeking a full-time Senior Telecommunications Expert to work at Intelcon's head office in Vancouver, with some international travel. An understanding of telecommunications policy and regulation, and sector reform is important. Strong communication skills, both in writing and oral presentation, are essential. We require a competent candidate who takes pride in his or her quality of work, who can handle deadlines and multi-tasking, is able to organise his or her work independently, and is capable of making a contribution to the team. Proficiency in French or Spanish would be an asset.
